Criminal Court Duty Lawyer

At the Magistrates Court the Duty Lawyer can help you with information about what happens in court and what you have been charged with.

If you have been served with a summons the Duty Lawyer can help you understand what it means. If you are eligible for a grant of legal aid the Duty Lawyer may be able to appear for you.

The Duty Lawyer will appear for you if you have been arrested and wish to apply for bail.

At the court, look for the Duty Lawyer signs or ask a member of the court staff to put you in contact with the Duty Lawyer. This service is free.

Family Court Duty Lawyer

At the Family Court anyone can ask for the Duty Lawyer for information about what happens in court and how to prepare for court. The Duty Lawyer is available on **all duty list days**.

The Duty Lawyer can give free advice and may, in limited circumstances provide assistance with preparing documents.

The **Hobart** Duty Lawyer is available for advice and assistance every **Monday** (except public holidays) between 1pm until 3pm and **Wednesday** 9:30am until 1pm and 2pm until 4pm.

The **Launceston** Duty Lawyer is available every **Monday** (except public holidays) from 9:30am until 12 noon and from 1pm until 4pm.

Family Violence—Safe at Home

The Safe at Home Lawyer can provide free advice, assistance and representation to victims of family violence in Hobart, Launceston, Devonport and Burnie.

The Safe at Home Lawyer can also provide appropriate referrals to the Court Support Liaison Service, the Family Violence Counselling & Support Service and the Police Victim Safety Response Teams.

Civil Advice and Minor Assistance

We can provide you with free advice and some assistance to better represent yourself in a civil claim, where you might be a claimant or a defendant. The lawyer can help you write a letter to negotiate a settlement or ask someone to pay for damage they have caused. The lawyer can explain the court process and procedure in simple terms.

Community Legal Education and Information

Community education and information sessions are run by our lawyers. The sessions are state-wide, free of charge and can be tailored to suit the needs or interests of your particular group. Call 1300 366 611 to book a session.
