Disability Royal Commission Advice Line

National Legal Aid has received funding to establish a telephone advice service to help people who want to participate in the Royal Commission into Violence, Abuse, Neglect and Exploitation of People with Disability.

The service provides advice to people with disability, and their families, carers, supporters and advocates. It will be able to explain legal rights and the options available to engage with the Royal Commission, including by making a submission, participating in a community forum, providing evidence at a hearing and sharing information about experiences. It will also be able to make referrals to counselling and other support services.



Legal Aid Board goes to Prison

In line with the commitment to gain a deeper understanding of the work we do and the challenges faced by our clients the Legal Aid Board held its July meeting at Risdon Prison.

Board members had an extensive tour of the prison which took in the different security areas, visitors centre, medical facilities and education resources. Following the tour we spoke with Ian Thomas, Director of Prisons.

It is always sobering to visit the prison but the tour provided a great insight into another aspect of the lives of many of our clients and their families.

Family Violence and Cross-Examination of Parties Scheme

People involved in Family Law proceedings, where allegations of family violence have been made, can no longer be directly cross-examined by the other parties. From 10 September 2019 where a cross-examination ban order is made any unrepresented parties will need to get a lawyer. Parties can apply for legal representation under the Commonwealth Family Violence and Cross Examination of Parties Scheme. A Register of Lawyers able to do this work has been created by Legal Aid.

There have been a number of orders made and we have already arranged representation for parties. We appreciate the support of private practitioners in establishing the scheme.

Community Legal Education Steering Group

We were pleased to host the first Community Legal Education (CLE) Steering Group meeting on 30 July.

Legal Aid joined with Community Legal Centres from across Tasmania to talk about what CLE we each provide and how we can work together to reach more people.

An audit of the CLE provided by Legal Aid and CLCs indicates that there is very little overlap. Information sheets are often used by many agencies and referrals are made to specialist services where necessary.

Legal Aid has been proud to join with the Women's Legal Service to deliver CLE sessions at Sheffield and Circular Head.
