

Reporting child sexual abuse to Police



Child sexual abuse is a crime in Australia. It includes grooming, sexual touching and sexual intercourse. It also includes making, possessing and sharing sexually explicit content of children such as photos, videos or writing.

Why report child sexual abuse to the police?

Under Tasmanian law you must report child sexual abuse to the police.

The police investigate crimes and collect evidence. This evidence can be used to prove what happened. The police may use the information you give them to help keep other people safe.

How to report child sexual abuse to the police

In an emergency, call 000.

If it is not an emergency, you can call Tasmania Police on 131 444 or go to your local police station.

Anybody affected by sexual harm can visit Arch in Hobart or Launceston for support options including sex crimes counselling and speaking with specialist detectives. More information is at www.arch.tas.gov.au.

You may find it helpful to write down what you want to say before contacting police. You can have a support person with you.

What happens when you report child sexual abuse to the police.

It will be up to the police and, where relevant, the Director of Public Prosecutions to decide whether to charge and prosecute someone for a criminal offence.
